75-acre Land Donation in the Notch



In December, the Conservancy received a donation of a 75-acre parcel in the Notch between Clarks Summit and Scranton. The land is directly adjacent to our Shepherd Preserve, a 42-acre parcel, and altogether they represent 117 acres of preserved land in the Notch! While the Shepherd Preserve is in South Abington Township, the new addition is all within the City of Scranton and extends over the top of the mountain and down to the Morgan Highway/State Route 307. Commuters along US Routes 6 & 11, Interstate 81, and the PA Turnpike, along with residents of Clarks Summit, Chichilla and Scranton will all be able to enjoy the preservation of this striking landscape.

The gift was made by Mr. Jeffrey Bagley and his family. The Conservancy wishes to express its profound gratitude to the Bagleys and to acknowledge the great generosity of this gift. The Conservancy is honored to be chosen as the steward of this piece of the Earth.

The donated land is well forested, with a healthy ground cover. The opportunity to protect this parcel reminds us of the overwhelming importance of protecting our steep slopes from erosion and our streams from sedimentation. The best use of this land, for the greatest benefit to society, is to preserve it intact with good forest cover. This will protect a small part of the Leggetts Creek watershed from erosion, pollution and negative visual impacts, and preserve this piece of a majestic landform. The Conservancy will ensure that this property is protected forever from subdivision and development.





Additionally, Mr. Bagley has agreed to allow a designated hiking access from the Morgan Highway, across the two small parcels that he still owns. This will allow hikers the opportunity to climb the steep hillside and enjoy the breathtaking views from the summit. The details of this access, along with the layout of the trails are still under development, and as such, are not yet open to the public. We will notify the community when access becomes publicly available.

We are glad to be able to help preserve this property, and deeply appreciate the honor and responsibility conferred upon us by the Bagley family.

GO GREEN BIKE TOUR—OCTOBER 7, 2012



Planning for Countryside Conservancy's third annual Go Green Bike Tour is well underway, and we promise this is the autumn event that you don't want to miss! Bring your road or mountain bike to Lackawanna State Park on Sunday, October 7, and experience firsthand the beauty of the Endless Mountains in October.

Beginner, intermediate and advanced bike routes will be available to accommodate riders of all abilities and preferences. Mountain bike routes will utilize the trails within the Lackawanna State Park/Countryside Conservancy trail system, ranging from a half-mile introductory ride for first-timers to an epic 18-mile single-track challenge for advanced riders. Road bike routes range from an 18-mile tour of the roads surrounding the State Park to a 62-mile Metric Century ride that will guide you through the backcountry roads of Lackawanna, Susquehanna and Wyoming Counties. Annual Tailgate Picnic Potluck Set for Sunday, September 16th



Meet at the South Shore Boat Mooring in Lackawanna State Park, off of Route 407 at 7:30pm on Monday evening. The rain date is Tuesday, July 3rd.


Women Teaching Women Biking Workshop

Trolley Talk – First Wyoming County Trail Easement Donated

On behalf of the Board of Directors, we would like to express our sincere appreciation to Mrs. Barbara Brown, of Clinton Township, for her recent donation of a trail easement of approximately 1,500 feet of trolley right-of-way on her property in Wyoming County (seven additional acres of Mrs. Brown's property were also preserved through a conservation easement in 2004). Barbara continues to conscientiously steward her land and is clearly committed to preserving it for future generations to enjoy. This

particular trail section abuts the Lackawanna Audubon lands at Davis Crossing Sanctuary and comprises one of the most scenic and peaceful properties along the former trail route. Original stone work, as pictured, remains intact from the trolley line which operated from 1908 until 1932.

This donation, finalized on February 22, 2012, is special to Countryside Conservancy as it represents the first trail easement in Wyoming County. This easement will one day be part of Phase 3 of our Trolley Trail project connecting Factoryville to Lake Winola. Although the current grant work is focused on Phase 1 (Clarks Summit to Dalton), the long range plan will be to connect Dalton to Factoryville and



Factoryville to Lake Winola. Work on trail easements and acquisitions continues to move forward on all three phases.

The Conservancy also wishes to thank Attorney Ty Welles who guided this trail easement to completion. The Conservancy Trail committee will carry forth the conditions presented within the agreement.



Grant Work Updates

This past spring and early summer have continued to bring much activity for the Conservancy's Trolley committee and staff.

Work has begun in earnest on our DCNR grant as final design plans are underway. Additionally, plans are being made by the Trail committee to schedule a trail ground-breaking event, by summer's end. Communication with local PennDOT representatives, as well as local municipalities and landowners has been occurring over the past few months.

In April, committee member Jeff Fleming and volunteers arranged a clean up and

clearing of the trail segment along Route 6 and Old State Road, owned by Mr. and Mrs. Cory Durso. This clean up coincided with the Earth Day weekend and was a part of the "Great American Cleanup of PA". The Conservancy was also present in Clarks Summit Borough this same weekend to share information on the trail project with the public in general.

Conservancy staff member Paul Maleski coordinated efforts with Mrs. Debbie Sweppenheiser and local girl scouts from the LaPlume area to tackle a clearing and clean up effort along West LaPlume Road. It is believed a small trolley station may once have stood on this site where a

small foundation remains. The Conservancy wishes to thank all for their efforts.

The Trail committee has recently completed a fundraising plan and will continue its efforts to raise the necessary match monies for grant compliance. Donations are welcome from all to assist in this endeavor.

Check the website for future trail work days as well as a formal date for the ground breaking ceremony. Once again, the Conservancy wishes to thank all who continue to support and participate in this project!

Watershed Coalition Receives DEP Grant

We are proud to announce that the South Branch Tunkhannock Creek Watershed Coalition, under the sponsorship of the Conservancy, was awarded a \$2,561 Pennsylvania Department of Environmental Protection (DEP) environmental education grant. The grant was announced on Earth Day and has since been approved. It will be used to purchase water testing equipment that can be used streamside and a display board with educational materials. The new equipment will make it feasible for the Coalition to hold educational outreach programs without the need of a lab.

The Watershed Coalition, an arm of the Conservancy made up of about twenty volunteers who have monitored the water in the Tunkhannock Creek watershed since 2004, is dedicated to preserving the health of the watershed that is at the core of the Conservancy's properties. Their primary focus is on collecting long-term chemical, physical and biological data on the condition of streams in the lower Tunkhannock watershed. The volunteers go out to eleven strategic sites once monthly from March to December, weather permitting, and collect water samples. They return to a makeshift lab and test the water for nitrates, phosphates, alkalinity, dissolved oxygen, total dissolved solids (TDS), pH and conductivity. With the advent of Marcellus shale drilling in the region, having baseline data has never been more important.

The grant runs from July 2012 through June 2013. During this time the Coalition will sponsor four educational activities for students on watershed testing. Angela Lambert, Environmental Education Specialist at Lackawanna State Park, will conduct a day long water testing workshop for approximately thirty students from Lackawanna Trail at the park in the fall. Coalition volunteers will use the new phosphate, nitrate and TDS meters to demonstrate water testing streamside. A similar program will be run by science teacher Megan Wolfe for 7th and 8th grade students from The Howard Gardner School at Keystone College, with Keystone education students assisting and observing.

One or two students from Lackawanna Trail High School will accompany the Coalition volunteers on their monthly sampling and testing as part of their senior project. Dale Holen, PhD and Associate Professor of Biology at Penn State University Worthington campus will mentor the students as they collect samples and perform all the same tests that our volunteers do.

In the spring we will join Cheryl Nolan, Watershed Specialist at the Lackawanna County Conservation District, at Lakeland School as part of their Earth Day Fair. The new equipment will be available for students to perform hands-on testing of water samples provided by the volunteers to demonstrate how the meters test for various water quality parameters. The new display board will provide additional watershed information at all of the programs.

If these educational activities prove worthwhile, as we expect them to, we hope to continue them in the coming years as part of our outreach to the community.
